CONSULTATION FEEDBACK

- The website recorded 916 users across 1,190 sessions.
- A total of 77 questions were submitted during the first webinar and 23 questions were submitted during the second webinar – 100 in all.
- 27 sets of detailed written feedback were received.







LOCATION OF FEEDBACK



Source of the Feedback Forms:

- Deepcut: 18 responses (66%)
- Heatherside: 6 responses (22%)
- Frimley Green: 3 responses (12%)

Summary of issues raised

A number of residents voiced concerns about Dettingen Park Estate being used for overflow parking for matches and whether the parking provision stated would be sufficient to facilitate all the requirements of multiple teams worth of vehicles. One resident asked whether the car park would be lit for evening users.

A number of residents raised concerns regarding the potential increase in traffic the proposals would bring to the area not only during the development process but also post completion – specifically vehicle access via Deepcut Bridge Road and increased traffic along Cyprus Road.

One resident, who thought the MUGA pitch is a good idea, asked whether it would be possible to also have a 4G football pitch incorporated into the plan. "There is a huge shortage of such facilities in the area and all are constantly booked up with plenty of other youth and adult football clubs looking for facilities"

One resident asked what the planned artwork installation is likely to be.

One respondent asked if there will be bicycle storage provision at the community sports hub.

One resident was supportive of the new Church Hall, however raised a concern as to whether it would be sufficiently large for weddings receptions and other large family events (Christenings etc).

Another respondent asked how the hall would be managed to avoid overlap of facilities, explaining that the Village has a number of halls with more potentially being built.

When asked about traffic calming measures, several respondents voiced concerns about the wider road network and how the traffic calming measures would mitigate increased traffic and congestion.

When asked about the footpaths through the Southern SANG and the SANGS link to the Central SANG, one respondent asked whether the path would be wide enough to not feel like a narrow corridor.

Two residents stated that they liked the proposals but said that the local community are desperately short of a Doctor's surgery as FGMC is full as is Heatherside Surgery. They asked if a space within the plans could be provided.





CONSTRUCTION COMMUNICATIONS

- In order to provided more frequent construction updates, Skanska is now producing monthly newsletters that:
 - Summarises works that have taken place in the preceding month and the works coming up in the month ahead
 - Details forthcoming community events
 - Provides a website link for signing up to e-newsletters and latest news stories.

This will be distributed to local households on paper to ensure direct reach.

Construction Update

 Ground remediation work will begin on the local areas for play (LAPS), Green Swathe and the southern sustainable drainage systems (SuDS).

We will carry out the safe removal and disposal of contaminated material.

- 1a The LAP is within the Central Suitable Alternative Natural Greenspace (SANG). There will be a slight increase of construction vehicles in this area but current access to the Central SANG will not be affected.
- 1b The Green Swathe is located between the two current CALA homes development sites and extends from the Village Green down to the Frimley Lock path. Access to the site will be via the Frimley Lock path which means an increase in the number of construction vehicles using the path to gain access to the site. Machinery will be operating Monday-Friday, between 8am to 5pm.
- 1c) The Southern SUDS is situated in the area of woodland between the Frimley Lock path and the Basingstoke Canal. Access to the site will be the same as the Green Swathe site detailed above.
- 2 The Mindenhurst team will be moving into their new project office in the former Premier shop building. The existing office located next to Mindenhurst Primary School will be removed.
- 3 Trenching works will continue from Deepcut Bridge Road, along Minorca Road, and in front of the cricket pitch site. This is for the installation of a water main to feed the residential houses and further developments

in this area. This will mean that during May there will be some traffic management measures in place along Minorca Road, which will include traffic lights and signage.

4 We will start trenching works along Blackdown Road, from the Sergeants Mess access on Blackdown Road, to Deepcut Bridge Road/North Access Roundabout. This trench will be tight to the kerb on the housing side of the carriageway and is necessary for

the installation of electrical cables to Substation 14 which will provide power to the local area.

Maintenance works, will be ongoing in the Central SANG. This will involve construction machinery operating in this area and will limit access to part of the SANG while work takes place. The majority of the Central SANG route will remain open for pedestrians.

Ecology – Bat Barn

We have recently completed the construction of a bat barn to re-home a group of brown long-eared bats. The bats were identified in one of the buildings and extensive surveys were carried out over a number of years to understand their population and behaviour.

Re-homing these bats has been necessary due to future construction activities that would disrupt them. We have therefore constructed a bat barn which is a timber building specifically designed to host this species of bats. This mitigation is being carried out under licence granted by Natural England.

The Brown Long-Eared Bat is a protected species in the UK and they are most commonly seen around April to October. As with all bats that live in the UK, they are nocturnal, but you might spot them at dusk when they come out to feed on midges and moths.

Construction Update



There is always a lot going on around Mindenhurst and Deepcut Village. Here are some of our main construction activities this month. with full details and further activities listed on our website.

Remediation will start to the Bovis Bank just off Newfoundland Road. All construction access will be through the Bovis site therefore there should be no additional

Upgrades to local roads. There will be road closures and which will affect those in MOD housing but not the Dettingen Estate. Residents will be notified

Water mains installation along Minorca Road. Trenching will stretch from Deepcut Bridge Road to the newly planned allotment parcel. Traffic management will be in place during these works.

Work begins on the Green Swathe.

The Green Swathe is the area located between the Cala housing areas. Machinery will be operating there during working hours and there will be an increase in

diversions as a result of this work prior to road closures.
